

Limestone FCU Stash Save Account Contest Rules

1. Eligibility

- a. This contest is open to members of Limestone Financial Credit Union who are 18 years or older. Employees of Limestone Financial Credit Union are not eligible to participate.

2. How to Enter

- a. Eligible members can participate by:
 - i. Opening a Stash Save Account during the contest period through the LFCU Mobile App.
 - ii. Completing an entry form with their name, address, phone number, and email, then submitting it into a designated entry bucket at any Limestone Financial Credit Union branch (no mail-in entries allowed).

3. Entry Period

- a. Entries will be accepted from June 1 through July 31, 2025. All entries become the property of Limestone Financial Credit Union and will not be returned. Limestone FCU reserves the right to end the contest early. Entries are subject to verification, and members may only enter once, regardless of the method used.

4. Winner Selection & Notification

- a. A winner will be chosen through a random drawing held the week after the contest ends. The winner will be notified via their contact information on file. If the winner does not respond within seven (7) days, an alternate winner may be selected. The odds of winning depend on the number of eligible entries received.

5. Prize Information

- a. One (1) Grand Prize Winner will receive a \$50 Amazon Gift Card. The prize is non-transferable and cannot be exchanged for cash. Limestone Financial Credit Union reserves the right to substitute the prize with one of equal or greater value if necessary.

6. Prize Delivery

- a. The prize will be awarded to the winner in person at a Limestone Financial Credit Union branch. Limestone Financial Credit Union is not responsible for lost or stolen prizes once they have been issued to the winner.

- a. No purchase or account opening is required to enter. By participating, entrants agree to comply with all contest rules.

- a. By participating, entrants release Limestone Financial Credit Union and its representatives from any claims related to participation in the contest or acceptance of any prize.

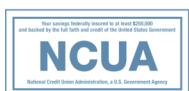
11. Verification & Disqualification
